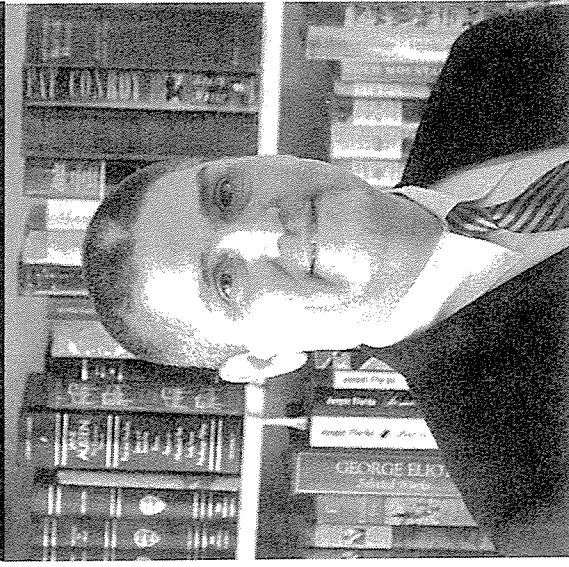

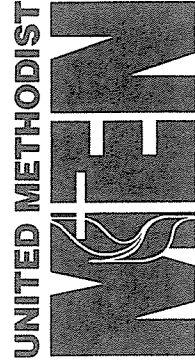

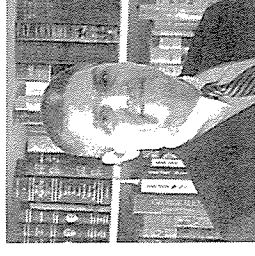

Rev. Dr. J. Maddox Woodbery, Jr.

The Rev. Dr. Jerry Maddox Woodbery, Jr. (Matt) is the son of the late Rev. Jerry M. Woodbery of Bainbridge, Georgia, and Martha Wells of Statesboro, Georgia. Matt Woodbery graduated from Kubasaki High School, Okinawa, Japan; Oxford College of Emory University; Emory College; and Candler School of Theology, Emory University. He earned his Doctor of Ministry degree from Wesley Theological Seminary, Washington, DC. Dr. Woodbery is a graduate of the U.S. Army Command and General Staff College and the U.S. Army War College. He is a member in full connection and an ordained elder of the South Georgia Conference of the United Methodist Church since 1987.

After graduation from seminary in 1985, Matt served as Associate Minister at First United Methodist Church, Americus, Georgia. In 1988, he received a U.S. Army commission as an Army chaplain.

Chaplain (Colonel) Woodbery (Retired) served in numerous assignments until his retirement in 2017. Most notable, he served as a battalion chaplain during Operation Joint Endeavor, Bosnia; lessons-learned team member in Operation Enduring Freedom, Afghanistan; brigade chaplain in Operation Iraqi Freedom, Baghdad, Iraq; garrison chaplain at U.S. Army Garrison Baumholder, Germany; deputy Joint Staff Chaplain, Office of the Chairman of Joint Chiefs of Staff, Washington, DC; installation chaplain, Fort Myer, Virginia; command chaplain, U.S. Army Japan, Camp Zama, Japan; and command chaplain, U.S. Army Intelligence and Security Command, Fort Belvoir, Virginia.

Matt's military awards include the Legion of Merit (two awards), the Bronze Star Medal, the Defense Meritorious Service Medal, and the Parachutist Badge.

Throughout Dr. Woodbery's Army career, he maintained a close relationship with the United Methodist Church through his endorsement by the United Methodist Endorsing Agency. For 10 years he served on the South Georgia Conference Board of Ordained Ministries. He and his family also remained connected to the larger church by actively participating in local United Methodist Churches when they were stationed within the North Georgia, South Carolina, and Virginia conferences.

Matt currently serves as the Director of Connectional Ministries for the South Georgia Conference of the United Methodist Church, Macon, Georgia.

Dr. Woodbery has been married for 33 years to the former Carol English of Cochran, Georgia. Their daughter, Callahan Woodbery, lives in Nashville, Tennessee. Matt and Carol reside in Macon, Georgia.
